The Government has declared the institution to be developed as a Post-Graduate Institute of Oncology Sciences and Research and major expansion in terms of infra-structure development and capacity building are being undertaken.

Faculty in MCC (PGIOSR) will have following opportunities:

- 1. An excellent clinical facility with well-established diagnostic services, research laboratories protocol based management system based on evidence based medicine.
- 2. Safe and congenial atmosphere to practice evidence based medicine under multidisciplinary umbrella
- 3. Out of box thinking is encouraged with opportunities for multi-institutional, multi-disciplinary collaborative researches
- 4. Professional growth and excellence are encouraged through well laid system

Job profile:

Every academic staff has clinical, academic, research and administrative responsibility. There should be keen interest and motivation in clinical and translational research, scientific writing and professional updating. Non-compromising professionalism and compassionate attitude towards patient care is a mandatory requirement for MCC faculty. The faculty shall be given responsibility of various training and academic programs and development of curriculum for training.

- 1. <u>Surgical Oncology:</u> The appointee will be posted in the Gastrointestinal oncology, Genito-oncology, Breast oncology, Thoracic oncology etc. He /she may be assigned responsibility of any of the units aforementioned. There are three dedicated state of art operation theatres with facilities for advanced minimal access surgery functioning on all working days. Robotic surgery experience is desirable. The department is a leader in oncologic robotic surgery, CRS+HIPEC, Limb salvage surgery etc Clinical research and assigned administration form core responsibilities. Opportunity to get involved in multicentre clinical trials and mentorship role in StartUp ecosystem do exist.
- 2. <u>Clinical Haematology:</u> Training in benign and malignant hematological disorders. It is desirable to have training in Bone marrow transplantation. The department manages hematological malignancies & benign hematological disorders. The department has performed over 250 bone marrow transplantation at an average of 30+transplantation per year. Around 50-80 day care chemotherapy are administered per day. The division has already started CAR-T Cell therapy. The faculties expected to be involved in industry sponsored and investigator initiated clinical trials. Availability of state of art molecular and genetic lab with NGS and molecular tumor board are other attraction.
- 3. <u>Nuclear Medicine:</u> Department plays a crucial role in diagnosing and treating various medical conditions using radioactive materials (radiopharmaceuticals) and imaging techniques. The primary roles are interpreting imaging studies, identifying diseases. Therapy, pain relief, patient safety and care, collaboration, Research and Development etc., Should have experience in PET-CT and Radionuclide therapy. The department has state of art facilities in Nuclear Medicine. It is one of the few centres performing high dose Iodine therapy, and other radionuclide treatment for various cancers
- 4. <u>Radiology/ Radiodiagnosis:</u> The Department is equipped with 3 Tesla MRI, Digital Mammography, 64 Slice CT Scanner, Dexa scan, USG, Intervention radiology including digital substraction angiography etc., the primary role is diagnosis, guiding treatment, preventive care & screening, Patient Safety and Radiation Protection, Interventional radiology, Emergency & Trauma care, Research and Education etc., The candidate is expected to have genuine interest in Intervention radiology and experience in the area is highly desirable.
- <u>5. Medical Oncology:</u> Medical oncology division deals with comprehensive evaluation and medical treatment of various types of solid in adults with chemotherapy, immunotherapy and targeted agents. Spectrum of cases seen in Medical Oncology division include Breast cancer, Gastrointestinal cancers, Lung cancer, Head and Neck cancers, Gynaecological cancers,

Endocrine cancers, Thoracic cancers, Genitourinary cancers, Brain cancers and cancers of bone and soft tissues. The division is well versed in administration of intraperitoneal and intravesical chemotherapy. The division closely associates with surgical oncology department in planning complex procedures like cytoreductive surgery with hyperthermic intraperitoneal chemotherapy in peritoneal surface malignancies. The division is involved in interdepartmental academics for training surgical, radiation and pathology residents in medical oncology. The division has experience with running early phase clinical trials, Phase 3 randomized control trials, both industry sponsored and investigator initiated multicenter clinical trials. The division has collaborated with numerous prestigious institutions across India for various clinical trials and collaborative studies.
